In one of the most successful turnaround efforts in its history, TransPar partnered with the Hawaii State Department of Education's (DOE) Student Transportation Services Branch to support a comprehensive reform its statewide school bus operations. The challenge was to rein in Hawaii's pupil transportation costs and improve their inefficient routing and outdated technology. The solutions provided by TransPar were exceptional starting with the reinvention of the DOE's transportation model. They added a flexible routing system, measurable processes and new procurement methods. TransPar's efforts resulted in \$16 million of cost savings, innovative technologies and improved statewide credibility.

"TransPar brought innovative ideas and a new approach to soliciting, contracting, overseeing and managing bus contracts and bus contractors," said James Kauhi, Manager of the DOE's Student Transportation Services Branch. "Quite frankly, they reinvented the transportation model here in Hawaii by becoming our partner."

A successful partnership between TransPar and **Normandy Schools Collaborative** enabled the St. Louis-area school district to overcome serious operational deficiencies in contracted school bus service and bring transportation in-house. The district faced the challenge of trying to provide great in-house student transportation after years of poor contractor service while recovering from uncontrollable costs and inconsistent service teamed with a lack of transportation expertise. TransPar came in and provided a new, in-house model, hired a Transportation Director, implemented a state-of-the-art routing system and instilled a forward-thinking mentality.

"TransPar did everything to help us get started. They told us what to do, how to do it and, in many cases, did it for us," stated Randal Charles, Assistant Superintendent of Operations for Normandy Schools Collaborative. "They even pulled TransPar employees from other locations to help staff phones the first week of school. We hadn't even discussed that; TransPar just did it because they knew it would make things go more smoothly. That kind of forward-thinking, and the relative ease with which it all happened, was impressive. Not only do these guys know their stuff; they're good people to work with."

An economic downturn, reduced school walk zones and a staff retirement gave Indiana's **Elkhart Community Schools** the opportunity to change the status quo and take a fresh look at its transportation operations. The District tapped TransPar to lead the way to greater efficiencies and tangible savings. Elkhart needed to sustain transportation and service in the face of reduced state funding and increased ridership.

In addition to overseeing, managing and supervising all aspects of the day-to-day operations of Elkhart's transportation system, TransPar analysts evaluated costs, policies, routing and technology. The results were significant savings in driver wages and operational costs.

The challenge was to make transportation affordable and manageable for Choice Schools in St. Louis while addressing unmanageable routes, driver shortages and lack of transportation expertise. TransPar provided customized solutions featuring a new, zone-based busing system and phased-in implementation. As a result, VICC gained manageable routes, shorter rides, efficient routing, a more affordable system and safe and on-time performance.

"The value of working with TransPar is tremendous. More than most school districts, transportation for the Choice Schools program is a big deal," stated VICC CEO David Glaser. "It's important it be done with excellence and is cost-effective. The way we've all been able to work together has been great. It's more of a partnership than a vendor relationship."
